Dual Citizenship Explained

- Citizenship is traditionally acquired by birth based on either the jus soli (right of soil) or the jus sanguinis (right of birth) principle.
- Nowadays, countries' laws provide for the right to choose the nationality of a state.
 - > However, there has been backward slide on citizenship policies (UK, Japan, Denmark, etc.)
- Dual Citizenship also means dual or multiple "Nationality".
- Benefits of Dual Citizenship provisions in the law:
 - Better propensity to Naturalize
 - > Promote economic and social assimilation
 - Employment and earnings gains

U.S. Laws on Dual Citizenship

- U.S. government does not require naturalized U.S. citizens to give up their citizenship in their country of origin
- The Oath of Allegiance to the United States speaks of renouncing "allegiance and fidelity" to other nations
- U.S. immigration law does not explicitly address the topic of dual citizenship.
- The best summarization of the U.S. government's position on dual citizenship lies in U.S. Supreme Court opinions (e.g. Kawakita v. United States, 343 U.S. 717 (1952) (extra-territorial laws), which explains that "a person may have and exercise rights of nationality in two countries and be subject to the responsibilities of both."
 - The Secretary of State is charged with "the determination of nationality of a person not in the United States," and "shall establish such regulations; prescribe such forms of reports, entries and other papers; issue such instructions; and perform such other acts as he deems necessary for carrying out such provisions" in accordance with Immigration and Nationality Act (INA) § 104 (8 U.S.C. 1104).
 - The Secretary is responsible for reviewing and approving or denying a properly completed request for a Certificate of Loss of Nationality of the United States (Certificate of Loss of Nationality)

Potential to lose U.S. citizenship

- INA 349, as amended, lists seven (7) potentially expatriating acts which, if performed voluntarily and with the intention of relinquishing U.S. nationality, may provide a legal basis for the U.S Government to approve a U.S. national's properly completed request for a Certificate of Loss of Nationality of the United States. The U.S. Department of State administers INA Section 349(a)(1)-(5); the Department of Homeland Security administers INA Section 349(a)(6)-(7).
 - > 349(a)(1) obtaining naturalization in a foreign state after 18;
 - > 349(a)(2) taking an oath, allegiance to a foreign state or subdivisions 349(a)(3) entering or serving in the armed forces of a foreign state engaged in hostilities against U.S. or serving as a commissioned or non-commissioned officer in the armed forces of a foreign state;
 - > 349(a)(4) accepting employment with a foreign government after the age of 18 if (a) one has the nationality of that foreign state or (b) an oath or declaration of allegiance is required in accepting the position;
 - > 349(a)(5) formally renouncing U.S. nationality abroad;
 - > 349(a)(6) formally renouncing U.S. nationality in U.S.
 - > 349(a)(7) if convicted of performing an act of treason against the U.S. or for attempting by force to overthrow,), which explains that "a person may have and exercise rights of nationality in two countries and be subject to the responsibilities of both."

Challenges of Dual Citizenship

Double Taxation risks

- U.S. worldwide income tax rule in addition to country where one maintain residence Double taxation avoidance treaty is not always there (e.g. with Nepal)
- Military Obligations
- Exempt from Certain Employment
 - Security Clearance or National Security job unless applicant surrenders foreign passport (citizenship) or obtains official approval for use.
 - Security Clearance Guidelines:
 - A: Allegiance to the United States
 - B: Foreign Influence
 - C: Foreign Preference (incl. organization involvement)
 - D: Sexual Behavior
 - > E: Personal Conduct
 - > F: Financial Considerations
 - G: Alcohol Consumption
 - H: Drug Involvement and Substance Misuse
 - I: Psychological Conditions
 - > J: Criminal Conduct
 - K: Handling Protected Information
 - L: Outside Activities
 - M: Use of Information Technology

Foreign Investment Policies of Nepal on NRN

- NRN Act and regulations
 - NRN ID NRN or NRN majority-owned company
 - 10 year visa
 - No Capital gain tax
 - National Treatment
 - Foreign Currency Account
 - Investment and Investment Gain Repatriation
 - Can undertake any Industry or profession as per Nepal citizen
 - To receive benefits as any other foreign investors
